The first monthly meeting of the Ellington Town Board was held on February 10, 2016 at 7:00p.m.at the Ellington Town Hall, 813 W. Main Street, Ellington, N.Y.

Supervisor opened the meeting at 7:00p.m. followed by the Pledge of Allegiance.

Public Participation

Steve Lundsten from Jensen-Haglund Monuments was present to discuss the Veterans Memorial monument that he would like to make for the Town Park. This has been discussed for many years but Steve was asked to come talk to the Town Board and discuss everyone's ideas on the monument and surrounding area. It was discussed that the monument that is in the Town Park now is made of wood and is deteriorating. Steve has large pieces of granite that he would like to make into a Veterans monument. His sons have also made a "rock" bench that he thought would look nice in the Park. Before this project gets started, most of the trees in the Town Park are very old or dying and need to be taken down for safety reasons. Discussed setting up a Committee to review the trees and the entire Town Board make a decision about the trees. Councilwoman Beightol would like to see the Town speak to a consultant about the removal of trees. Councilman Rhinehart will call Forecon to see if they provide a consulting service. A grant to purchase trees or help pay for a planting plan as a Community project was discussed. Resolution No. 2 - 2016, entitled "Application for an Urban Forestry Council Arbor Day Program Community Grant" was read by the Supervisor.

Highway Superintendent Report

When getting ready to place the new brine tank on the truck, it was discovered that the frame needed to be rebuilt and sprayed at Line-X. Report of water running down Harris Hollow Rd, found tube plugged and needed excavator to unplug and fix shoulder. Highway Supt. attended mandatory training for alcohol/drug testing. Truck #9 needed repairs to a water holding tank. Highway did some brush & tree work on the cemetery driveway.

Also did tree work on Waterman Road which will be ditched this summer. They fabricated "headlight guards" for the excavator. The "wing" project on the Lo-Pro has been completed. Still hauling salt and sand but well within the budget. Supervisor asked Hwy. Supt. about the mower attachment he had discussed previously. Town Board members received an informational flyer on this new mower to review and discuss.

They are asking for the Town to have only 4 Band Concerts on Saturdays this year and they will have movie night, at their expense, on the 5^{th} Saturday. In exchange they are asking for the Town to pay the \$450. towards a band that will play at Town Picnic. They also discussed ways to get funding to keep the Picnic going, fireworks, etc.

Motion made by Rhinehart, seconded by Miles to give Town Picnic \$450. towards a band for Town Picnic for just this year.

A Representative from TPS propane products talked to the Supervisor asking if the Town was going to bid for petroleum products this year. Flyer advertises \$1.39/gal for residential and he promises that they can do better for a municipality. This price was checked against our current costs by Lictus and we are at State bid or below now.

Councilman Chase discussed a program, Board Docs, to place agendas and minutes for the Town Board members online was discussed. It would cost \$1,000. to set up and \$3,000. a year. They would train us and also set up a demo. He will research other companies that do this.
