The large tube project on Dean School Road has been finished with the help of shared services from Town of Gerry. We went to Charlotte to help with blacktop. We have also been doing a lot of ditching and have placed 3 more driveway tubes.

Helped Cherry Creek with roadside project. There is a logging project starting in 2 weeks on Dean School road. Weather has finally given highway a break.
