The highway crew has been busy plowing, salting roads. Sand and salt have been hauled in to fill the shed back up for next year. They have also been hauling stone for the summer projects. The town surface treated roads have not fared well over the winter. The request for sealed bids for the highway roof was printed in the Post Journal. A new

heater control box was put in truck #9 and maintenance was done on all other trucks. Truck #5 is down with a broken front spring and is currently at Fat Cats for repair.
